In terms of section 3 (1)(b) of the Project and Construction management professions Act (Act 48 of 2000), the SACPCMP Council must also consist of two professionals in the service of state nominated by any sphere of government.

In terms of section 4 (1) of the Project and Construction management professions Act (Act 48 of 2000), when any nominations in terms of section 3(1)(b) become necessary, the SACPCMP Council must, amongst others, invite the State to nominate within a period of 60 days from the date of invitation, persons who qualify for nomination in terms of section 3(1)(b)

Nominees must be registered in one or more of the following professional categories recognised by the SACPCMP: Construction Manager, Construction Project Manager, Construction Health and Safety Agent, Construction Health and Safety Manager, or Construction Health and Safety Officer. Nominees must hold a minimum NQF Level 7 qualification recognised by the Council for registration purposes and must have at least ten (10) years' professional experience. Board experience will be an added advantage.

The South African Council for the Project and Construction Management Professions (SACPCMP) hereby invites members of the public to nominate suitably qualified persons for consideration for appointment by the Minister of the Department of Public Works and Infrastructure to serve as members of the 7th Term Council of the SACPCMP.

In terms of section 3 (1)(c) of the Project and Construction management professions Act (Act 48 of 2000), the SACPCMP Council must also consist of two members of the public nominated through an open process of public participation.

In terms of section 4 (2) of the Project and Construction management professions Act (Act 48 of 2000), when any nominations in terms of section 3(1)(c) become necessary, the SACPCMP Council must invite the public to nominate within a period of 60 days from the date of invitation, persons who qualify for nomination in terms of section 3(1)(c)

Nominees must be South African citizens, ordinarily resident in the Republic, must meet the prescribed requirements, including a minimum NQF Level 7 qualification, and a minimum of ten (10) years' professional experience at management level. Suitable nominees should have expertise in one or more of the following areas: governance, legal, corporate services, finance, human resources, marketing, communications, risk management, audit, ICT, forensic investigation, education, pedagogy, curriculum, and research or policy development in the quality assurance of learning programmes. Board experience will be an added advantage. Public professional registration with relevant statutory bodies in the nominee's area of practice will also be an added advantage.

PURPOSE

The purpose of this correspondence is to invite Registered Persons and Voluntary Associations to nominate representatives to serve as Council Members for the seventh term of office for the South African Council for the Project and Construction Management Professions (SACPCMP).

BACKGROUND

2.1. In terms of section 3 (a) of the Project and Construction Management Professions Act (Act 48 of 2000), the Minister of the Department of Public Works and infrastructure is to appoint six (6) Registered Persons, excluding candidates, of whom: at least four (4) must actively practice in the project and construction management professions; and who must be nominated by the Voluntary Associations and/or any Registered Person; and who must represent the categories of Registered Persons contemplated in section 18, in the prescribed manner.

2.2. In terms of section 4 (1) of the Project and Construction Management Professions Act (Act 48 of 2000), the SACPCMP must, amongst others invite Voluntary Associations and Registered Persons to nominate, within a period of 60 days from the date of invitation, persons who qualify for nomination in terms of section 3(1)(a) to serve on the seventh term of office.

2.3. The term of office of members will be four (4) years, calculated from the date of appointment of such members by the Minister. The Council will meet at least four (4) times per annum, and the appointed person will, in addition, be required to serve on sub-committees of the SACPCMP.

2.4. To comply with the procedures prescribed in the Project and Construction Management Professions Act (Act 48 of 2000), the cut-off date for the nomination has been determined as **25 September 2026**.

REQUEST

3.1. To assist the SACPCMP in compiling a list of nominees for appointment to the Council, you are requested to submit nominations before or on **25 September 2026**. This would enable the Minister of the Department of Public Works and Infrastructure to appoint the appropriate representatives to serve as Council Members of the SACPCMP.

3.2. To ensure an adequate combination of skills and expertise, the following statutory requirements apply.

Disqualification from Membership of Council and Vacation of Office

In terms of section 6 (1), A person may not be appointed as a member of the Council if that person-

- (a) is not a South African citizen and ordinarily resident in the Republic;
- (b) is an unrehabilitated insolvent;
- (c) has been convicted of an offence in the Republic, other than an offence committed prior to 27 April 1994 associated with political objectives, and was sentenced to imprisonment without an option of a fine, or, in the case of fraud, to a fine or imprisonment or both;
- (d) subject to subsection (3), has been convicted of an offence in a foreign country and was sentenced to imprisonment without an option of a fine, or, in the case of fraud, to a fine or imprisonment or both;
- (e) has, as a result of improper conduct, been removed from an office of trust; or
- (f) has, in terms of this Act, been found guilty by the disciplinary tribunal or the council of improper conduct.

Each nomination must be in writing and must contain the following information in the prescribed format and detail required by the Council:

1. Completed and duly signed acceptance form by the nominee that incorporates a declaration that the nominee has not served on Council for two consecutive terms and is not disqualified in terms of the provisions of the Act.
2. Brief (maximum of five pages) Curriculum Vitae (including attached certified copies of qualifications and ID, not older than three months).
3. Signed conflict of interest declaration form.

For your convenience, the nomination form, related documents and reference to the SACPCMP Act (No 48 of 2000) have been attached for ease of reference. Completed nominations must be submitted on or before **25 September 2026**. Late or incomplete nominations will not be considered.
